### CHECK-IN ON FIRST DAY OF CAMP

Day Camp check-in on Monday is from 9:15 to 9:55 AM. Campers should arrive no earlier than 9:30 on Tuesday through Friday. Please do not arrive at the camp before the times stated. Pick-up time is 3:00 PM sharp.

It is the parent's responsibility to make sure their child is checked in every morning when they arrive at the camp. Do not just drop a child off.

Only authorized persons will be allowed to check a child out.

# CAMPERS MUST NOT BRING

lPods, cell phones, electronic games or gadgets. All such items will be collected and stored by the camp director (including cell phones).

The elders of the Rolling Hills Church of Christ oversee the Rolling Hills Bible Camp.

All staff and teachers are members of area churches of Christ.

PLEASE READ ALL THE RULES FOR CAMP Keep this brochure for reference to rules & what to bring and not bring to camp.

### **BULES ABOUT OF OTHING**

No flip-flop type shoes; tennis shoes are recommended. All pants must be to the knee. All clothing must be modest. NO LEGGINGS, tank tops, midriff tops, halter-tops; no t-shirts with sleeves and/or sides ripped out, or see-through tops. Skin should not be visible between shirt and pants.

Clothing with alcohol and/or tobacco advertisement or inappropriate wording will NOT be permitted. The camp director may ask you to change if you are deemed immodest or inappropriately dressed. Parents and visitors on campus are asked to abide by the camp dress code.

### CAMP DISCIPLINE

First Offense — Campers will go before camp director and senior counselor. Camper will be given verbal warning, rules will be clarified, and meeting will be documented.

Second Offense — Parents will be called in for a conference.

Third Offense — Parents will be asked to pick up camper.

No destruction of property will be tolerated. Parents may be charged for damages of property.

Illegal activity will be reported to the proper authorities.

### LEAVING THE CAMPGROUNDS

If campers must leave the campground for sports or other activities, **they must inform the director** and sign out. Parents should inform the director and sign the camper back in when they return.

Parents must submit in writing the names of any persons with whom camper will be allowed to leave. The person picking up the camper is responsible for signing the camper out/in and informing the director each time.

Identification will be required for any person picking up campers unless known by the director or other adult staff.

Campers are expected to remain on camp premises at all times.

# Special Notice about Day Camp

We have a water play day but the exact day depends on the weather. **On Monday**, each child needs to bring a change of clothes and a towel. These should be tied in a cloth bag (something other than a Wal-Mart sack), with the child's name clearly marked on the bag. The clothes will be returned in the same bag.

Parents are invited to a program on Friday night at 6:30 PM at the Rolling Hills church building where the children perform songs they learned at camp. Following the program we invite you to a wiener roast at the camp ground, weather permitting. Second grade campers and parents are invited to tour a cabin in preparation for next year's overnight camping experience. # VISITOR POLICY

It is the responsibility of the camp staff to protect your child while at camp. Our staff has submitted to a national background check and training. Visitors coming and going puts your child at risk. A change in visitor policy is now in effect as follows:

Parents, grandparents, and guardians of an overnight camper may only visit on Tuesday during meal time in the Canaan building. Visitors must leave the campground once meal time is over. If you would like to eat a camp meal on Tuesday night, you must pay for the meal during registration on Monday morning. The meal is \$10.00 a person. No other persons are permitted to visit during the week and permitted visitors are restricted to Tuesday lunchtime.
